# What is the purpose of this update?


# **Description of this fund**

This life cycle investment stage invests 80% in the Lifestages High Growth Fund and 20% in the Lifestages Income Fund, which is regarded as providing appropriate levels of risk and return for a person aged 35-44.

# What are the risks of investing?

Risk indicator for the Lifestages Auto Option age 35 - 44:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


# How has the investment option performed?

# Example of how this applies to an investor


Hayley had \$10,000 in the investment option at the start of the year and did not make any further contributions. At the end of the year, Hayley incurred a loss after fund charges were deducted of -\$1,069 (that is -10.69% of her initial \$10,000). Hayley also paid \$24.00 in other charges. This gives Hayley a total loss after tax of -\$1,168.56 for the year.

#### **Currency hedging**

As at 30 September 2022 the investment option has an exposure to foreign currency assets of 74.06%, of which 31.53% was hedged back to NZD. This means the investment option's foreign currency exposure is 42.53%.
