# **Investment Update**

## What is the purpose of this update?

This document tells you how the Lifestages Auto Option age 50 -54 has performed and what fees were charged. The document will help you to compare the fund with other funds. SBS Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

This life cycle investment stage invests 80% in the SBS Wealth High Growth Fund and 20% in the SBS Wealth Income Fund, which is regarded as providing appropriate levels of risk and return for a person aged 50-54.

# What are the risks of investing?

Risk indicator for the Lifestages Auto Option age 50 - 54:



### Example of how this applies to an investor


Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$2,027 (that is 20.27% of her initial \$10,000). This gives Hayley a total return after tax of \$1,889.00 for the year.

#### **Currency hedging**

As at 30 September 2024 the investment option has an exposure to foreign currency assets of 78.33%, of which 42.18% was hedged back to NZD. This means the fund's foreign currency exposure is 36.15%. - <sup>1</sup> Note that market indices reflect no deduction for charges and tax.
- <sup>2</sup> This covers expenses incurred in running the fund (e.g. accounting, audit, and regulatory compliance costs). This also covers the Supervisor's annual fee (for the services it provides) and an estimate of fees and expenses incurred by the underlying funds. GST will be included in some expenses, where applicable. Our estimates are made on the basis of reasonable assumptions about the ongoing level of fees and costs expected to be charged (taking into account the actual fees and costs as a percentage of average net asset value that were charged for the most recent scheme year). These fees are deducted from, and reflected in the unit price of the fund.
