## What is the purpose of this update?

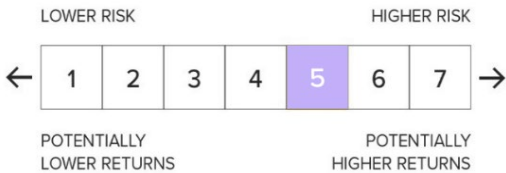
## Description of this fund

The Strategy aims to achieve high capital growth and returns over the long term. The Strategy invests into the following SBS Wealth funds: 60% into the World Equity Portfolio; 20% into the Australasian Equity Portfolio; 12% into the World Bond Portfolio; and 8% into the New Zealand Bond Portfolio.

## What are the risks of investing?<sup>1</sup>

Risk indicator for the Growth Strategy:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

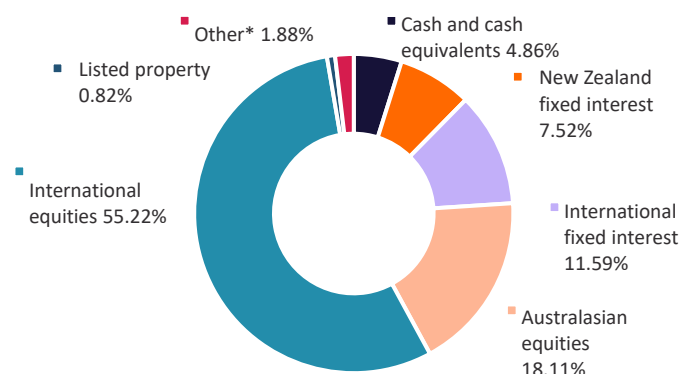
## Example of how this applies to an investor<sup>5</sup>

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return of \$749 (that is 7.49% of her initial \$10,000). This gives Hayley a total return of \$748.51 for the year.

## Currency hedging

As at 31 March 2025 the investment option has an exposure to foreign currency assets of 75.47%, of which 40.11% was hedged back to NZD. This means the fund's foreign currency exposure is 35.36%. ## Notes

- <sup>1</sup> As this Strategy started on 27 June 2024, five-year actual returns for the Strategy are not available. To calculate the risk indicator for the five-year period ending 31 March 2025, market index returns have been used up to 26 June 2024 with actual Strategy returns used for the balance of the period. As a result of those market returns, the risk indicator may provide a less reliable indicator of the potential future volatility of the Strategy.
- <sup>2</sup> As this Strategy started on 27 June 2024, annual fund charges of the investment option for the year to 31 March 2024 are not available. The charges reflect the fees disclosed in the PDS dated 2 September 2024 instead.
- <sup>3</sup> Includes GST.
- <sup>4</sup> This covers expenses incurred in running the Investment option (e.g. accounting, audit, and regulatory compliance costs). This also covers the Supervisor's annual fee (for the services it provides) and an estimate of fees and expenses incurred by the underlying funds. Our estimates are made on the basis of reasonable assumptions about the ongoing level of fees and costs expected to be charged (taking into account the actual fees and costs as a percentage of average net asset value that were charged for the most recent scheme year). These fees are deducted from, and reflected in the unit price of the fund.
- <sup>5</sup> As the Strategy started on 27 June 2024, an annual return for the Strategy for the year ended 31 March 2025 is not available. For the purposes of the investor example, the return is the actual return of the market index for the period 1 April 2024 to 31 March 2025 with no deductions for charges and tax.
- <sup>6</sup> The investment option invests in the following SBS Wealth funds: 60% in the SBS World Equity Portfolio; 20% in the Australasian Equity Portfolio; 12% in the World Bond Portfolio; and 8% in the New Zealand Bond Portfolio. The actual investment mix, target investment mix, top 10 investments and currency hedging all reflect the assets invested proportionally in these SBS Wealth Funds.
