What is the purpose of this update?

This document tells you how the Lifestages Auto Option age 65+ has performed and what fees were charged. The document will help you to compare the fund with other funds. SBS Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

This life cycle investment stage invests 30% in the SBS Wealth High Growth Fund 55% in the SBS Wealth Income Fund and 15% in the SBS Wealth Cash Fund, which is regarded as providing appropriate levels of risk and return for a person aged 65+.

What are the risks of investing?

Risk indicator for the Lifestages Auto Option age 65+:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the investment option performed?

This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 30 September 2025.


Example of how this applies to an investor

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$666 (that is 6.66% of her initial \$10,000). This gives Hayley a total return after tax of \$544.42 for the year.

Currency hedging

As at 30 September 2025 the investment option has an exposure to foreign currency assets of 57.99%, of which 45.29% was hedged back to NZD. This means the fund's foreign currency exposure is 12.70%. Notes

¹ Note that market indices reflect no deduction for charges and tax.

² This covers expenses incurred in running the fund (e.g. accounting, audit, and regulatory compliance costs). This also covers the Supervisor's annual fee (for the services it provides) and an estimate of fees and expenses incurred by the underlying funds. GST will be included in some expenses, where applicable. Our estimates are made on the basis of reasonable assumptions about the ongoing level of fees and costs expected to be charged (taking into account the actual fees and costs as a percentage of average net asset value that were charged for the most recent scheme year). These fees are deducted from, and reflected in the unit price of the fund.

³ The investment option invests 30% in the SBS Wealth High Growth Fund, 55% in the SBS Wealth Income Fund and 15% in the SBS Wealth Cash Fund. The actual investment mix, target investment mix, top 10 investments and currency hedging all reflect the assets invested proportionally in these SBS Wealth Funds.

* This investment option was established in December 2022. Under the FMCA 2013 the historical returns contained in this document must reflect the disclosures that would have applied had the option been in existence when Lifestages Auto was established in 2015.
